AREAS OF APPLICATION

SCALP ACTIV+ SURFACE DISINFECTANT is a type TP2 and type TP4 bactericidal, sporicidal, fungicidal and virucidal disinfectant. It is designed for cleaning and disinfecting all surfaces: floors in contact with shoes and pets, walls, doors, door handles, counters, chairs, tables, desks etc. For surfaces that may come into contact with food, always rinse off product after application.

APPLICATION

1. DILUTION: Ready-to-use product.

2. APPLICATION EQUIPMENT: Manual sprayer, spray, cloth.

3. OPERATING PROCEDURE: Apply to surfaces and materials to be treated. Spray on surface to be disinfected and leave to work. Clean off any excess product using a clean cloth.

4. APPLICATION TIME: This solution works by impregnation.

5. APPLICATION TEMPERATURE: 5 °C to 50 °C. Effectiveness is reduced at extreme temperatures.

6. TOOL CLEANING: Clean tools with water straight after application.

7. YIELD: About 0.5 L of product per 10 m².*

8. STORAGE: Store product in frost-free premises, away from the elements and direct sunlight. Do not store at temperatures <5 °C.

APPLICATION PRECAUTIONS

1. PROTECTION OF SURFACES: Avoid splashing on surrounding vegetation.

2. PROTECTION OF PERSONS: In the event of splashing on the skin or face, wash thoroughly with water.

3. SOILED PACKAGING: Must be totally emptied out. After cleaning with a suitable detergent, packaging may be reused. Unused product must be destroyed by incineration at an approved centre. The packaging may be discarded as non-hazardous waste under the full responsibility of the owner of this waste. Residue must not be poured down the drain or into watercourses.
