AREAS OF APPLICATION

This product is designed for stripping building paints, thick plastic coating, waterproofing and thin films on plaster, concrete, stone and brick surfaces. This super-boosted stripper is a true alternative to chlorinated strippers. Its white, gel formula and creamy texture make it extremely easy to apply with a roller, brush or pneumatic gun.

APPLICATION

<u>1. DILUTION</u>: Ready-to-use product.

<u>2. APPLICATION EQUIPMENT</u>: Natural-fibre brush, could be sprayed using an airless spray gun (see #6).

<u>3. OPERATING PROCEDURE</u>: Mix product well. Apply a thick coat then leave product to work until coating has completely softened (see application time below). Rinsing is recommended. Thoroughly clean away all stripping residue.

<u>4. APPLICATION TIME</u>: Depending on the type of coating and its thickness, leave to work for an average of 2 hours. Open time: 8 to 24 hours, depending on weather conditions.

5. APPLICATION TEMPERATURE: -5 °C to 50 °C.

6. PRODUCT CAN BE USED MECHANICALLY: Graco Mark V type equipment with nozzle (537). Pressure: 70 bars. 3 crossed coats 40 cm away from the surface. Yield: 800 g / m², 100 to 120 m² covered in an hour. Protect surfaces: rubber / plastic / vegetation.

7. TOOL CLEANING: Straight after use with water and detergent.

8. YIELD: Between 700 g and 1 kg / m², based on the type of coating*.


