AREAS OF APPLICATION

SCALP ANTI-GRAFFITI 49 removes all types of graffiti on surfaces protected with VERNASOLV PU 31 and VERNAEAU PU 16, or on delicate surfaces such as wood, bodywork, road signs (carry out tests beforehand).

APPLICATION

- 1. DILUTION:** Ready to use.
- 2. TOOLS:** Natural fibre roller, brush, or cloth.
- 3. METHOD:** Miix well. Apply SCALP ANTI-GRAFFITI 49 to the graffiti with small circular movements. Leave to act. Wipe with a cloth or high-pressure rinse. Renew the operation as necessary. On resistant graffiti, use SCALPNET EDJ 28.
- 4. APPLICATION TIME:** From 10 to 20 minutes.
- 5. APPLICATION TEMPERATURE:** From 5 to 50°C. Efficacy is reduced at extreme temperatures.
- 6. CLEANING OF TOOLS :** Clean tools in water immediately after use.
- 7. APPLICATION RATE:** About 300 g/m².*
- 8. STORAGE :** Store the product in a frost-free location where it is protected from the weather and away from direct sunlight.
