AREAS OF APPLICATION

SCALPIK L16 NG is a pickling solution specially designed for pickling varnishes and paints on wood.

This innovative product is free of chlorinated solvent and is a perfect replacement for liquid methylene chloride paint pickling supports.

APPLICATION

DILUTION: Ready to use, do not dilute.

APPLICATION EQUIPMENT: in a pickling bath.

OPERATION METHOD: Fill the bath with SCALPIK L16 NG. Soak the pieces to be subjected to the pickling solution in the bath. Leave the pieces in the bath until full pickling of all paint layers. Take out the parts and rinse with pressurised water.

APPLICATION TIME: the time required for complete pickling varies from one to several hours.

APPLICATION TEMPERATURE: room temperature.

YIELD: about 100 g/m² depending on the nature of the paint to be subjected to the pickling solution.

ADVICE: it is strongly recommended to aerate the workplaces in order to evacuate the residual vapours.

CLEANING THE TOOLS: the tools must be cleaned with water.

STORAGE :

- Min storage temperature: + 5 ° C
- Max storage temperature: + 25 ° C
